Fee Information and Services

Intake September 2026

EBS Universität für Wirtschaft und Recht is responsible for the invoicing and collection of students' tuition fees. Payments are invoiced by and payable to EBS in three instalments over the duration of the Executive MBA programme per the payment schedules below.

Early Application Tuition Fee 1 – through 31 March

The Early Application tuition fee for academic applications received no later than 31 March 2026 for the 18-month course of study commencing September 2026 is €38,950.

Standard Tuition Fee – through 31 August

The standard tuition for applications received between 1 June 2026 and 31 August 2026 for the 18-month course of study commencing September 2026 is €44,950.

The one-time, non-refundable enrolment fee is applied towards the tuition fee. The tuition fee is to be paid in advance of each semester in three payments to EBS. EBS confirms that the tuition fee for students who commence studies in September 2026 and successfully complete this part-time graduate programme within the 18-month duration will not be increased during this period.

Deferrals / Temporary Suspensions

Students who once admitted to the programme may wish to defer the start date to the following year must submit a written request for consideration. All deferred offers will be reconsidered under the prevailing entry criteria when the admissions process opens for the following year.

Scholarship awards may not be deferred to a following year and are awarded on a strict “use it or lose it” basis.

In the event students may decide to defer admission to the following year or request a temporary suspension of studies once admitted to the programme due to personal or professional circumstances, the prevailing tuition and fee schedule in effect at the time students either initiate, or resume studies will apply respectively.

Services and Offerings Included in the Programme Fee

The tuition fee includes the following:

- Programme delivery, including course instruction, workshops, etc.
- Teaching materials, including case studies, etc. per module requirements
- Accommodation during both UK residential stays; typically, 6 nights during the first-year residential and 4 nights during the second-year residential
- Lunch and refreshments at module sessions conducted at EBS
- External executive training delivered in the context of an Outdoor Development programme, including the fee, transportation to and from the off-site venue in the English Lake District or other UK location, as well as accommodation and meals at the training venue
- Partial defrayal of costs of optional occasional events, which may from time to time include guest speakers, a company visit, local outings, historic tours or outdoor excursion, dinners held on the EBS campus and at area venues. As the programme subsidises a portion of some events, the per-student cost per optional event may range from € 0 to € 25 per event
- Personal support from faculty and the programme directors

What's Not Included

- Textbooks (most are for optional reading, and several can be accessed as e-books)
- Travel costs for all core modules, elective modules, and the New Venture Creation elective module (San Francisco), as well as all local transportation
- Any accommodation expense other than that listed above. Students cover their accommodation expense for core modules taken at EBS, as well as electives taken at Durham and any international elective(s) offered
- Meal expenses other than lunches. Occasional dinners may, however, be provided from time to time by the programme.
